Learning Module Descriptions

The JDEdge curriculum is divided into five primary learning modules. Each module focuses on a different set of related law school skills. With a mix of pre-recorded videos, independent work, and live classes (that are also available to view on demand), the modules in JDEdge can be adapted to fit your schedule. While flexible enough to allow you to choose your own path, we recommend following the order of the syllabus to ensure you get the most out of the course.

Module One: Introduction to Law School and Law School Learning

What's it all about? The first module will provide you with an introduction to law school. You will engage in lessons on where to go for help within your law school community, an overview of the judicial system, and some important legal terminology.

Module Two: Preparing for Class

Wondering how a law school class is different from other classroom experiences? Module Two will answer most of your burning questions about what to expect in class. You will learn how to best prepare, how to get the most out of the class experience, and what to do afterwards to make sure the learning sticks. Lessons in Module Two include case reading and briefing, the Socratic method, note-taking, rule synthesis, and creating study materials.

Module Three: Preparing for Exams

It's not too early to think about work habits and techniques that can set you up for exam success. Module Three focuses on preparing for exams. Here, you will engage in lessons on writing for law school exams, effective study and memorization techniques, and the importance of taking practice exams. You will also have the opportunity to prepare for – and take – a practice exam.

Module Four: Preparing for Law Practice

How do you achieve your goal of becoming an attorney? The fourth module focuses on preparing for law practice, with lessons on time management, stress management, professional expectations, landing your first legal job, and creating your own professional development plan.

Module Five: Preparing for Licensure

This final module focuses on getting your law license, the character and fitness process, and the bar exam. You will also be introduced to resources from MAX by AccessLex® about financing your legal education and the bar study process.
